DOWNLOADING THE APK

Step 1: Download the APK from the [Google Drive](#) . Download the latest APK to your system.

Step 2: Launch the RealWear Explorer 4.0 or later.

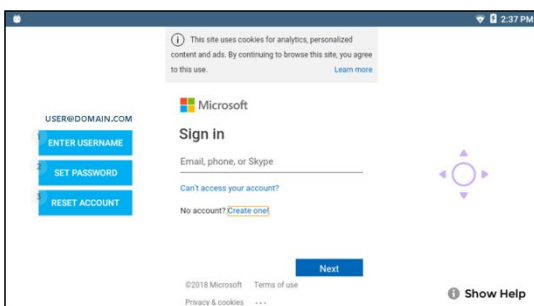


Figure 1. Initial Microsoft Login Screen

Step 3: Drag and drop the APK on the top right corner of RealWear Explorer window. (Figure 1)

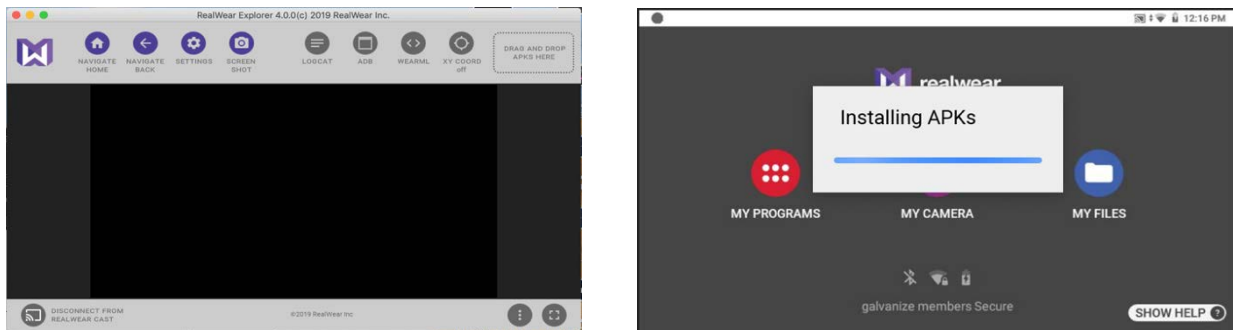

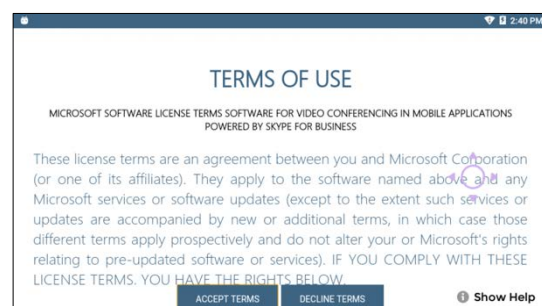


Figure 2. EULA Acceptance Screen

Step 4: Accept the Terms and Conditions. Say, "OK" (Figure 2)

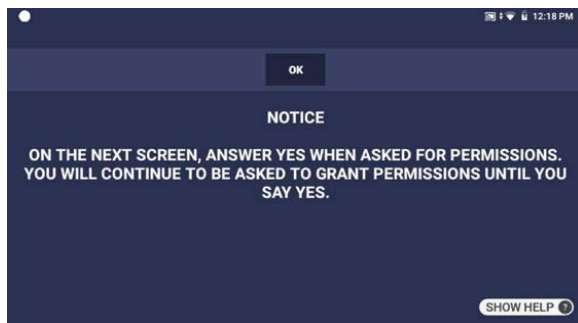
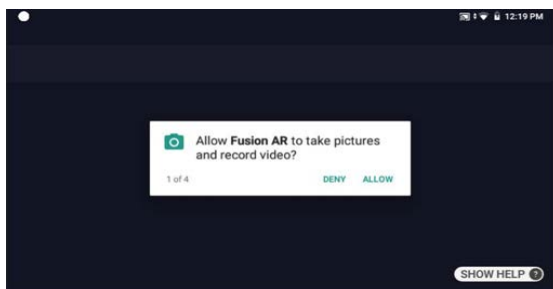


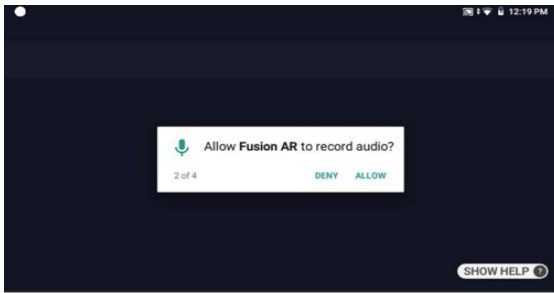

Step 5: Answer the 4 next questions to allow the Fusion AR to access the device for:

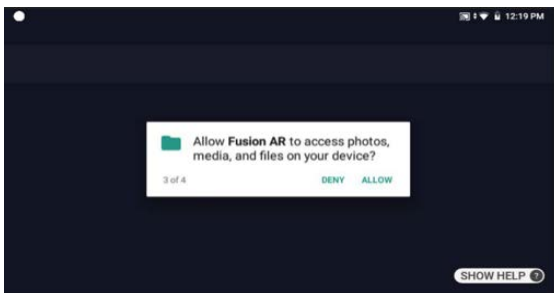
1. Allow Fusion AR to take Picture and record Video? Say: "Allow"



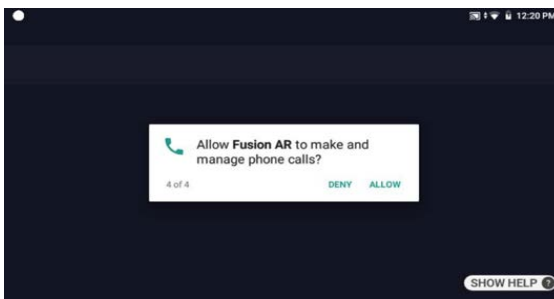
2. Allow Fusion AR to record Audio. Say: “**Allow**”



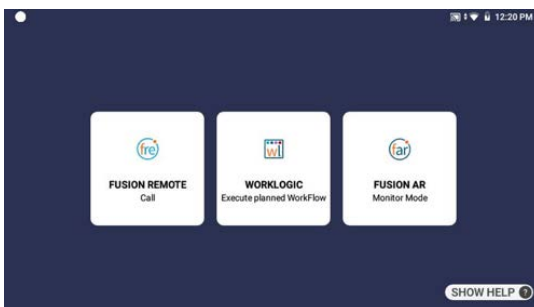
3. Allow Fusion AR to access photos, media, and files on your device? Say: “**Allow**”

HOW TO PREPARE SKYPE FOR BUSINESS USER'S CREDENTIALS FOR USE WITH FUSION REMOTE

ONLINE SKYPE FOR BUSINESS ORGANIZATION

- Step 1: Generate the QR Code*¹ corresponding to your SfB username and password, using the following web service: <https://fusionremote.YourDomain.com/> For POC and Trials, please access the page at <https://fusionremote.jujotech.com>
- Step 2: On the web page, select the button “Skype for Business Credentials”
- Step 3: If you have an Online Skype for Business Organization, select “Online Skype for Business” on the top dropdown-box
- Step 4: Enter your Skype for Business Username and Password and hit Encrypt
- Step 5: Save or Print the displayed AES encrypted QR Code
- Step 6: After launching Fusion Remote, Say, “Scan QR Code” to scan the QR code you have generated and proceed with authentication

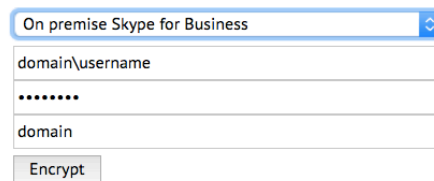

Step4: Enter your Skype for Business Username, Password, and Domain (domain\username) information; hit Encrypt

Step 4: Save or Print the displayed AES encrypted QR Code

Step 5: After launching Fusion Remote, Say, “Scan QR Code” to scan the QR code you have generated and proceed with authentication

HOW TO LAUNCH FUSION REMOTE ON THE HMT


- Step 1 **“Navigate Home”**: to access the Home Screen (*Figure 1*)
- Step 2 **“My Programs”**: to access the Launcher Screen (*Figure 2*)
- Step 3 Locate Fusion Remote icon  on the HMT Application Screen (*Figure 2*)
- Step 4 **“Fusion Remote”**: to start the application

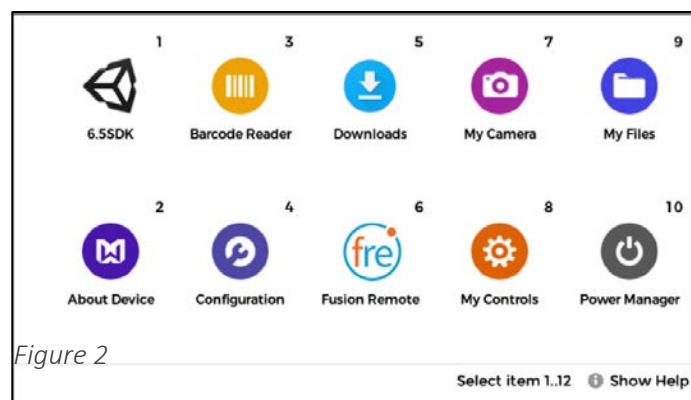

HOW TO ACQUIRE USER'S SKYPE FOR BUSINESS CREDENTIALS

Once Fusion Remote has launched for the first time, the Scan QR Code Panel is displayed, as shown in *Figure 1*

Step 1: **“Scan QR Code”** to open the integrated Barcode Scanner, as shown in *Figure 2*

Step 2: Focus the target are on the QR Code and wait for the HMT feedback sound

Step 3: Once the QR Code is acquired and credentials verified, the username is displayed in Microsoft Skype for Business Login screen.

For On-Premises Skype for Business Organizations, authentication will immediately follow Step 3 and the user will be presented with the Contact List Screen on successful authentication. Please proceed with Section E **“How to operate the Contact List”** in this case.

For Online Skype for Business Organizations, authentication will follow the steps described in Section D **“How to Authenticate on Microsoft Online Skype for Business Organization”**.

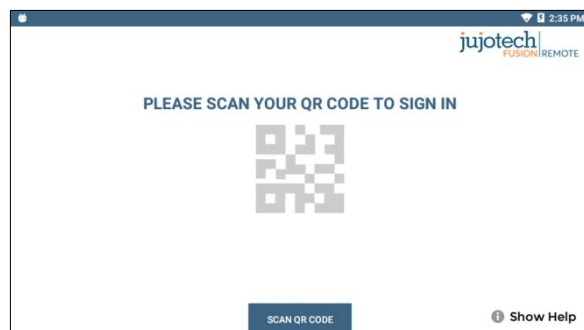

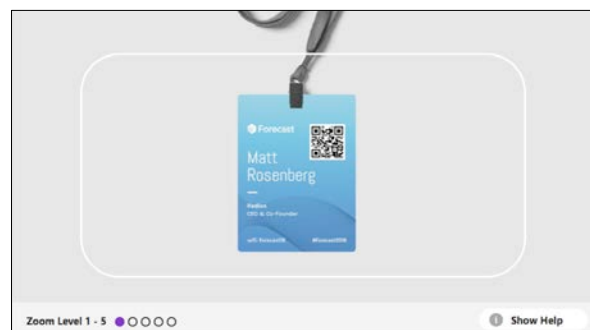

HOW TO AUTHENTICATE ON MICROSOFT ONLINE SKYPE FOR BUSINESS SERVER

Once Fusion Remote has launched for the first time, the Scan QR Code Panel is displayed, as shown in *Figure 1*

Step 1: **“Enter Username”** fills in the username field

Step 2: **“Next”** proceeds to step 3

Step 3: **“Set Password”** fills in the password field

Step 4: **“Sign In”** executes authentication. If successful, proceeds to step 5; otherwise reenter password (Step 4) or restart from Step 1, as instructed

Step 5: **“Yes”** maintains authentication after exiting Fusion Remote and proceeds to step 6

“No” requires authentication after exiting Fusion Remote and to proceeds to step 6

Step 6: **“Accept”** completes process and proceeds to Contact List

“Cancel” cancels the process and returns to Step 1

HOW TO OPERATE THE CONTACT LIST

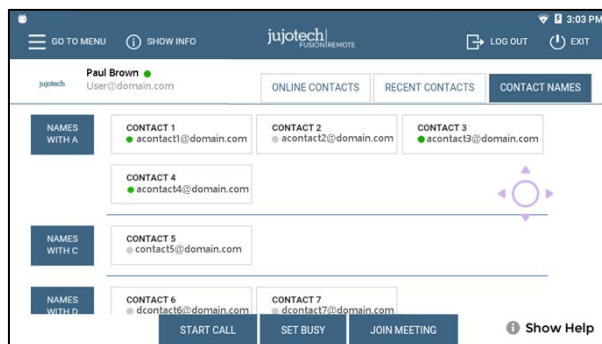


Figure 1. List of Contacts

Upon successful authentication, the user's list of SfB contacts will be displayed, along with user's presence and login info (upper right corner in *Figure 1*) and actions

Contact list can be filtered using the following voice commands:

"ONLINE CONTACTS" **online** contact ordered alphabetically

"RECENT CONTACTS" **recent** contact ordered alphabetically

"CONTACT NAMES" **all** contact ordered alphabetically

"CONTACTS WITH <letter>" to scroll the list to the first name starting by <letter>

"PAGE UP/DOWN" to scroll up/down a long list of contacts

A contact name can be selected even if not in the visible portion of the Contact List

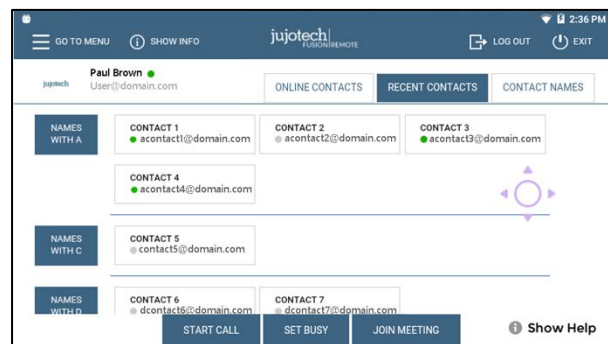


Figure 2. Ordered List of Contacts

HOW TO INITIATE A MEETING

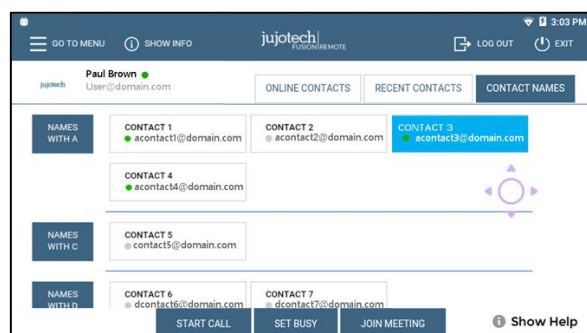


Figure 1. Call initiation

Step 1: **“SELECT <contact full name>”** or **“SELECT contact <number>”** starts a call (Figure 1).

In case of selection error, simply repeat. The selected contact will be highlighted

Step 2: **“START CALL”** initiates a call with the selected contact

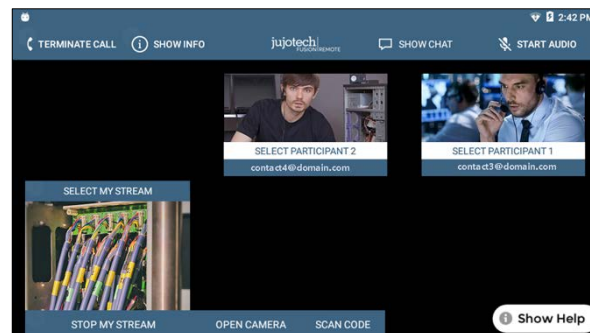


Figure 2. Participants selection during multicast

The interface during a live call (Figure 2) offers the following commands:

“STOP/START AUDIO” manages the HMT microphone

“STOP/START STREAM” manages the PIP Stream

“SELECT MY STREAM” selects the HMT stream to full screen

“SHOW INFO” displays Information Panel

“SHOW/HIDE CHAT” shows/hides the Instant Messaging panel

“STOP CALL” stops the call

“SHOW PARTICIPANTS” shows Participants Panel

“SELECT PARTICIPANT <number>” or **“SELECT <participant name>”** selects the stream <number> to full screen

LIVE CALL – HOW TO USE THE INSTANT MESSAGING

Text messages can be exchanged between the Remote Expert and the Fusion Remote user using the following voice commands:

Step 1: **“Show Chat”** opens the Instant Messaging panel

Step 2: **“Write Message”** writes a message to the Remote Expert

Step 3: **“Dictation”** starts dictating the message

Step 4: **“Accept”** enters the text into the message

Step 5: **“Send Message”** sends the message to the meeting chat

Step 6: **“Hide Chat”** hides the Instant Messaging panel

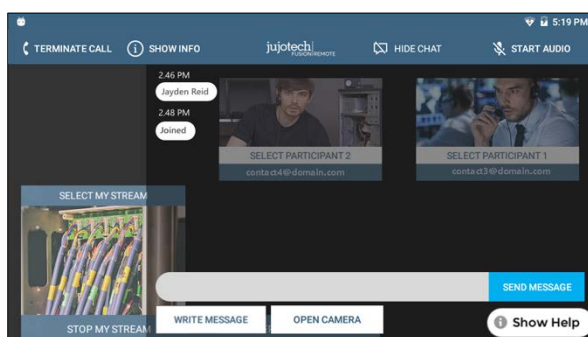


Figure 1. Instant messaging

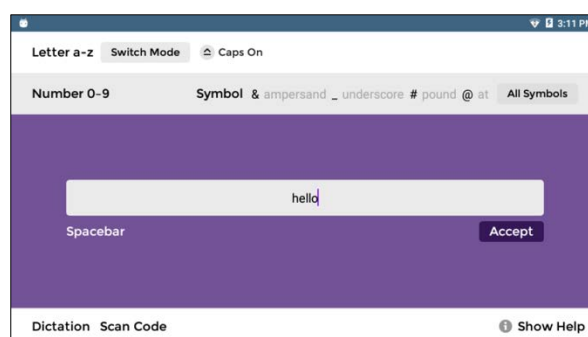


Figure 2. Message dictation

LIVE CALL – HOW TO CAPTURE AND SHARE AN IMAGE

Images can be captured and exchanged between the Remote Expert and the Fusion Remote user using the following voice commands:

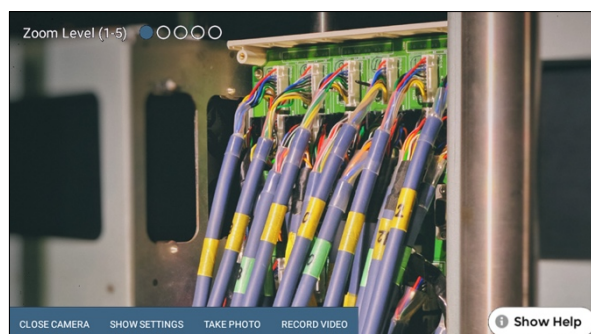


Figure 1. Camera Panel

- Step 1: **“Open Camera”** opens the HD camera (*Figure 1*). This command is also available in the Chat Panel
- Step 3: **“Take Photo”** captures a still image (*Figure 2*). The image is immediately uploaded, and a URL is placed on the meeting chat for downloading. Multiple images may be captured and uploaded
- Step 4: **“Record Video”** records a video clip. Maximum duration can be selected in the Settings Panel and the default length is set to 15 seconds. Multiple video clips can be recorded and uploaded
- Step 5: **“Close Camera”** closes the Camera Panel

Additional commands:

“Show Settings” opens camera settings panel. This command is also available in the Main Menu panel (from Contact List/Goto Menu)

“Zoom Level <number 1-5>” executes the desired zoom level on the camera image

WORKLOGIC

Jujotech WorkLogic enables full enterprise integration of existing actionable workflows and actionable IoT via open API ingestion. WorkLogic provides rich media annotation at the edge with workflow accomplishment. Best in class voice control for hands free workflow:

- Step by step instructions
- Checklist & forms
- Troubleshooting decision trees
- Standard operating procedures

Tasks and troubleshooting activities are optimized, reducing human error and significantly increasing overall efficiencies.

Jujotech WorkLogic loads XML workflow files that must be compliant with the following specific rules set forth in this document under the heading of “validator”.

The type of workflow is customer specific and the format is depended on the customer choice on the workflow editor. There are some editors in the market that have a capability of generating the work flow in XML format. In the cases that the customer does not have the capability of translating the workflow to XML format, Jujotech offers this service of generating XML files from any format of workflow. Additionally, Jujotech offers an XML “validator” to ensure the XML file is in the correct format for WorkLogic consumption.

All the commands are presented as the use cases in an effort to help in the training of user and helping them in understanding the system.

VALIDATOR

The Validator is located in the (<https://fusionremote.jujotech.com/validator.php>). Prior to uploading the Workflows, one needs to ensure the compliance of the XML file to WorkLogic system.

To implement a workflow in WorkLogic framework it needs to be written in XML format with a predefined schema.

The following tags needed in the **workflow** definition.

- Id attribute, unique for all workflows, a best practice to build unique workflow is to use organization name and workflow identification inside organization: orgname_workflowid;
 - **Version** attribute;
 - **Title** attribute;

Each workflow tag could have:

- **steplist** attribute in order to:
 - show it with true value;
 - not show it with false value;
- **mentors** list attribute.
- **enable** attribute in order to:
 - enable the workflow with true value;
 - disable the workflow with false value.

The **workflow** children tag may be:

Workflow Connections:

To create a connection between workflows, in each workflow could be present a list of workflows to enable when the current workflow is done. The workflow tag has a child **enable_wf_list** tag with several child **wf_to_enable** tags, each for every workflow to enable.

Each workflow is composed by several steps, it's possible to add **steps** tags as a child of workflow with:

- **n** attribute to define which is the step,
- **level** optional attribute to assign a level of criticality for the step (level=0 Normal, level=1 Critical, and so on).

You have to add at least one step.

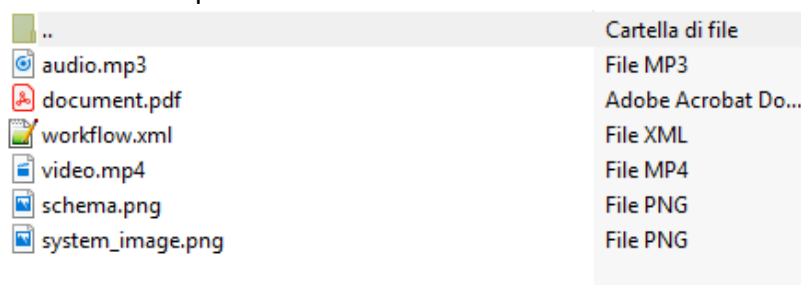

XML Workflow and asset files must be compressed in a ZIP file.

This zip file must have the following properties:

- All files must be inside the root folder
- No subfolders are allowed
- Audio format must be mp3
- Video format must be mp4
- Image and schema format must be jpg or png
- Document format must be pdf



To browse workflow using Jujotech Worklogic, user has to load ZIP file in One Drive space.

ZIP files must be stored in WORKLOGIC_WS folder inside the root of One Drive space.



USERS OF THE SYSTEM

The field worker is the principal users of the WL. It is intended for performing the Standard Operating Procedure (SOP) on the field.

WORKLOGIC FLOW/STEPS

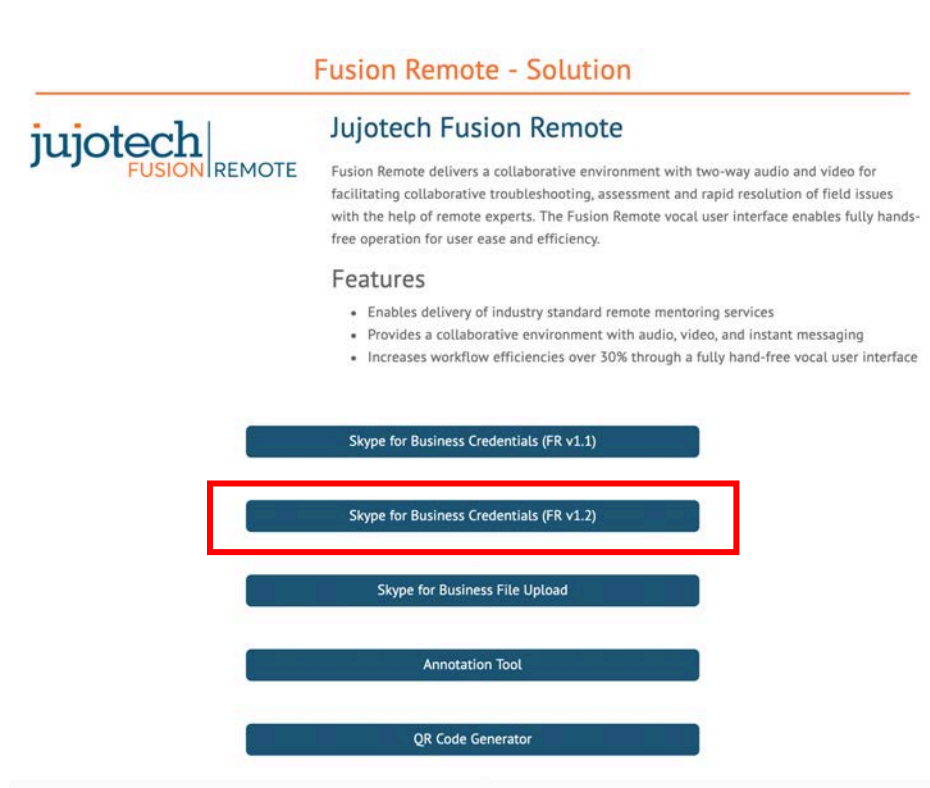
(all commands and activities are performed by Voice command)

1. AUTHENTICATION (FIELD WORKER)/ LOGGING IN

1. The field worker Logs-in using QR Code. Access to the OneDrive.

The QR code can Load the all relevant WorkFlows for the current SOP.

1. Generated by System Admin based on the Microsoft credentials and access to the One Drive or on premises repository.
2. Generated by field worker through [FusionRemote](#) website. “generate QR code”



2. The field worker Logs-in with Skype For Business (SfB) credentials.

This feature is required for connecting to remote mentor. (process described in detail at **Fusion Remote** section)

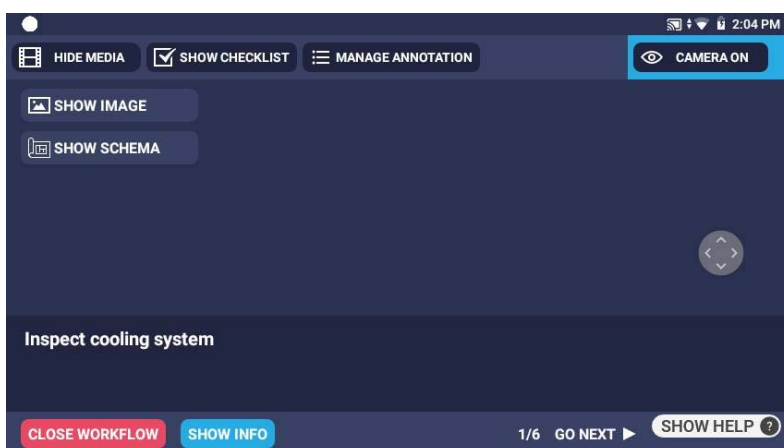

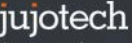

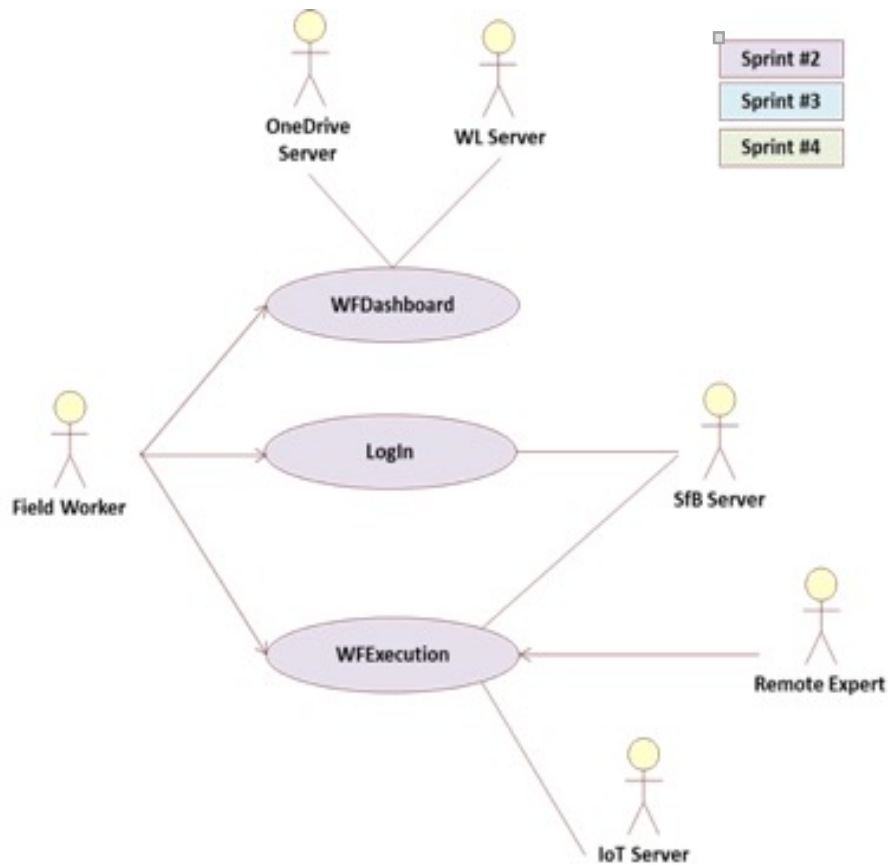


Figure 1 Use Case Mode

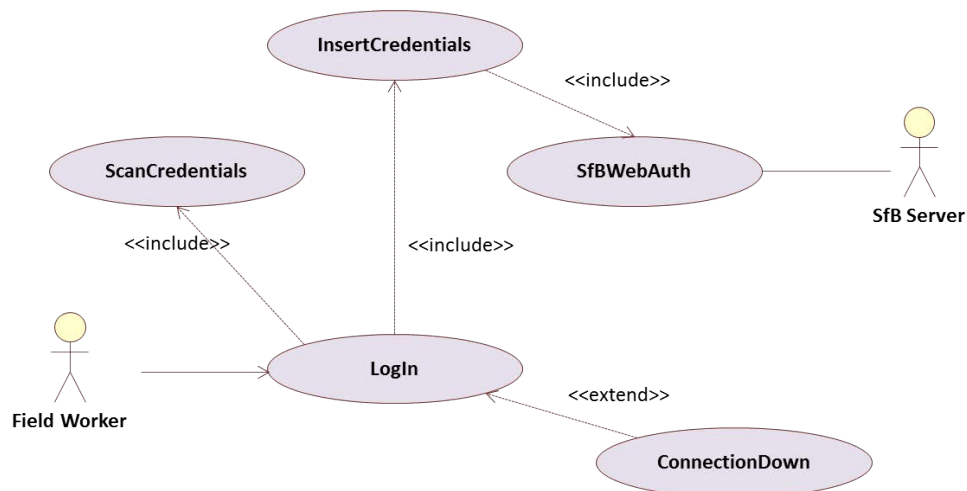


Figure 2 Use Case – Login

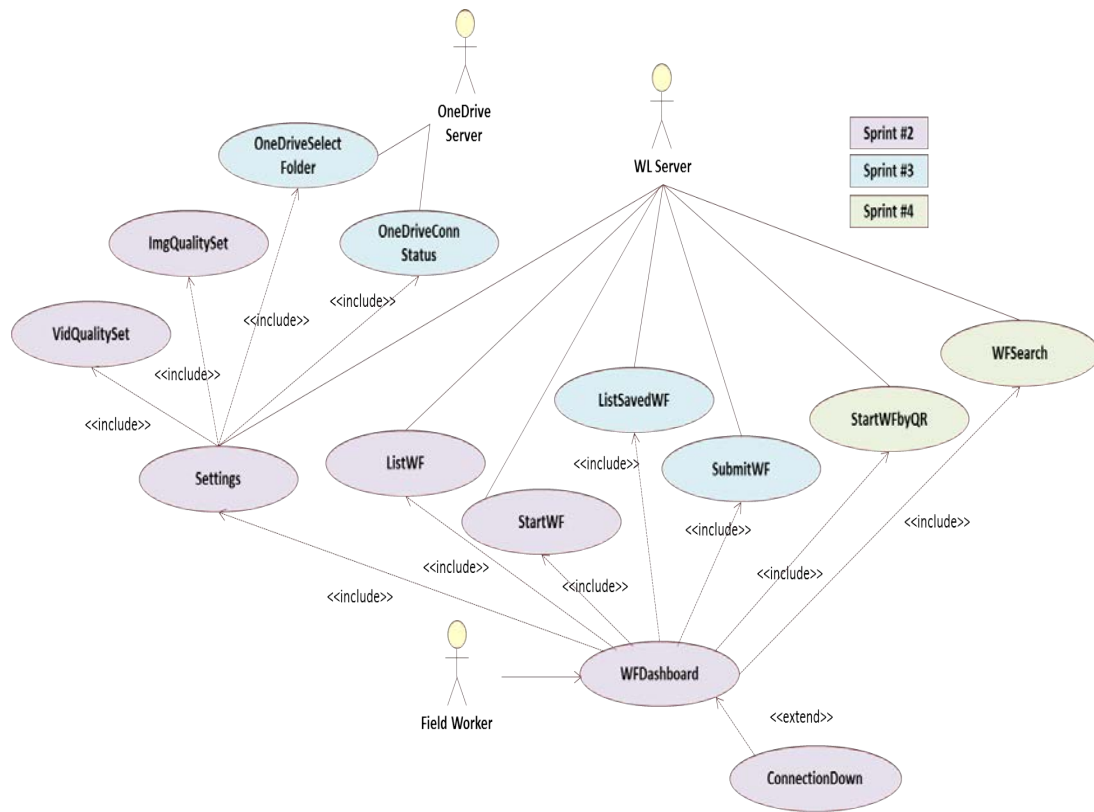


Figure 4 Use Case – WFDashboard

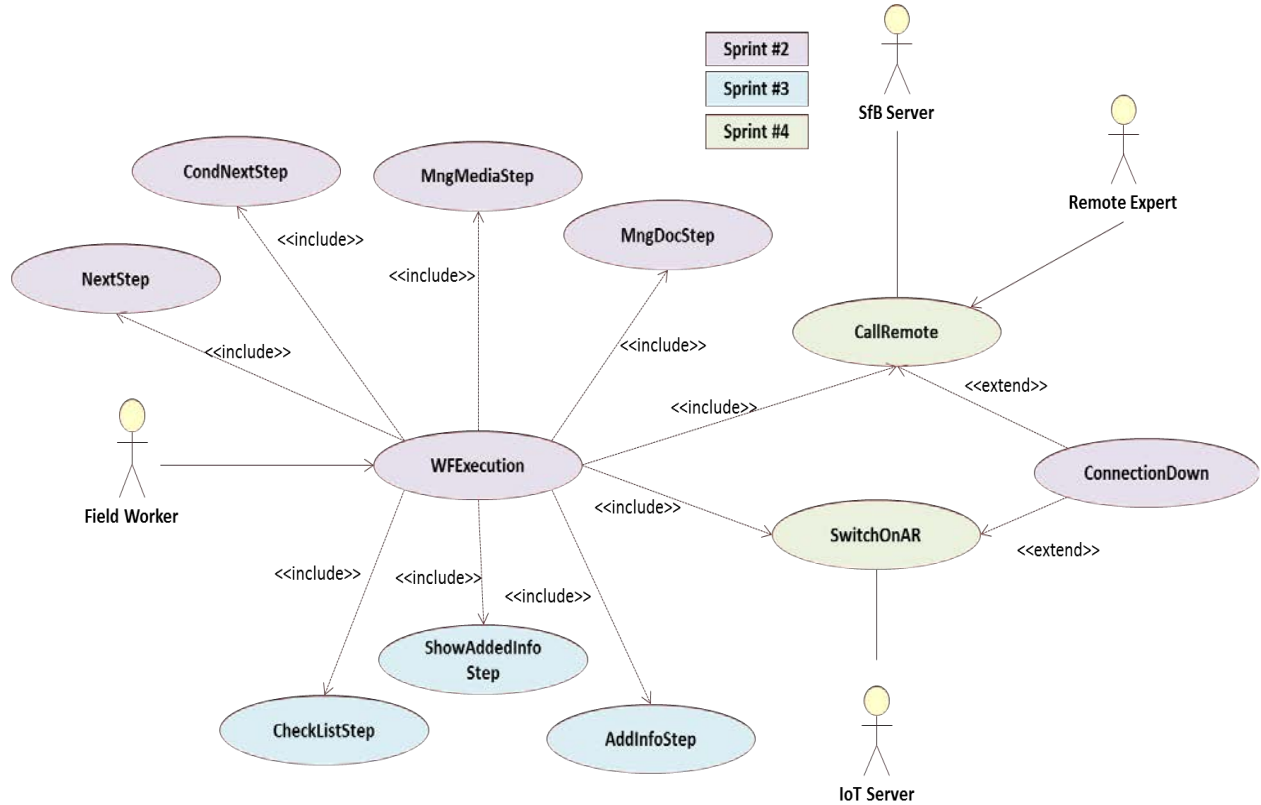


Figure 5 Use Case – WFExecution
